# YOUR RESPONSIBILITY TO APPEAR FOR THE CITATION

- The appearance date can be found on your citation. The Court gives you a (10) ten-day grace period (Calendar days) to appear or pay. It is the final date that is considered "on time".
- You may appear at any time during regular business hours Monday- Friday 8:00am to 5:00pm if you should have any questions or want to pay your citation. You may also call the office at (956)425-7131.
- Any request pertaining to your citation must be done with the Honorable Judge Ruben Ochoa during Court hours Monday or Thursday at 5:00pm (to appear at 4:30pm)
- Failure to appear on or before the court date will result in a warrant to be issued for your arrest and additional fees to be applied for failure to appear.
- A TELEPHONE CALL is not considered an appearance.



- A Failure to Appear (FTA) charge plus additional fees will apply and a warrant being issued
- Request to the Texas Department of Public Safety for the denial of driver's license renewal
- Request to Scofflaw for the denial of vehicle registration renewal

If you desire to resolve your citation without appearing before the Judge, you must enter a plea of Guilty or No Contest and pay your accessed fines on or before the appearance date.

# OPTION 1: PLEAD NO CONTEST OR GUILTY & PAY

- APPEAR IN PERSON Come by the Town of Combes Municipal Court during business hours (Monday to Friday 8:00am to 5:00pm) Location: 21626 Hand Rd Combes, TX 78535
- APPEAR BY MAIL- You may submit your payment & plea.
  - To confirm amount to be paid and request plea form to be sent via email or fax, call the office at (956)425-7131.
  - Send check or money order for full payment made payable to: "Town of Combes Municipal Court"

- Pay over the Phone with Debit or Credit Card (Convenience fee of \$3 for every \$100 will apply)
- PAYMENT PLAN AND COMMUNITY SERVICE AVAILABLE UPON REQUEST DURING COURT HOURS (for eligibility application must be filled out and submitted to clerk prior to court appearance)

# OPTION 2: REQUEST DEFENSIVE DRIVING COURSE

- APPEAR IN PERSON DURING COURT HOURS (Monday or Thursday only @ 5:00pm)
- A request for this option must be done on or before the appearance date. A Driving Safety Course will not be granted after the due date. You must be eligible and meet all requirements:
  - Must be at least 17 years of age
  - Do not possess a Commercial Driver's License
  - Must have a current driver's license and insurance
  - Must not have been charged with speeding in excess of 24 mph over the speed limit and violation was not conducted in a construction zone
  - Must not have taken a Driving Safety Course within the last 12 months to dispose of a citation.

### OPTION 3: REQUEST DEFERRED DISPOSITON (30-60 day probationary period, pay full fine)

- Must have current liability insurance
- Must have valid Driver's License
- Must be at least 17 years of age
- Do not possess a CDL license at time of offense
- Must not have received any citation for a moving violation during the past 6 months within the State of Texas
- Must not be participating in a Deferred Disposition in another court
- Must not have been charged with speeding in excess of 24 mph over the speed limit nor occurred in a construction zone

# OPTION 4: PLEAD NOT GUILTY & REQUEST A PRE-TRIAL

- To contest a citation and plead not guilty, you must appear in court before the Honorable Judge on or before your appearance date. An attorney may be retained whom should submit a letter of representation to the Court on or before the appearance date. Court hearings are not scheduled by phone.
- If a Court date is set, options are no longer valid unless authorized by the Honorable Judge
