New Combes Road-Requesting reimbursement of Subdivision Plat Fees of \$1,920.00 dollars. The owner has cancelled the platting of the subdivision.

Action for Approval or Disapproval of.

The City Administrator Ms. Aida Gutierrez explained to the city council that the subdivision was initially approved at the Commissioner's meeting on April 23,2023. The property owner Mr. Rene Estrada requested the cancellation of the platting process in July 30,2024. To date, the City of Combes has not made any improvements therefore Mr. Rene Estrada sought reimbursement of \$1920.00 (one thousand nine hundred twenty dollars) for the subdivision fees. The City Administrator Ms. Aida Gutierrez recommended that the \$150.00 (one hundred fifty dollars) plat review fee and \$100 (one hundred dollars) administrative fees not be reimbursed. Balance for reimbursement \$1670.00 (one thousand six hundred seventy dollars), Discussion among the city council and city counsel Mr. Gilberto Hinojosa pertaining to prior discussion, approval, and application for Agenda item #8.

The City Administrator Ms. Aida Gutierrez explained to the city council the reason for the item to be tabled was due to obtaining more proposals for the installation of Solar Street Lights, due to highest bid was \$45,650 (Forty-five thousand dollars six hundred fifty dollars). The city council's packet obtained several quotes for the breakdown of the installation of 17 Solar-Powered streetlights on Hand Road. Discussion was made among the city council pertaining to the quoted dollar amounts, the qualifications and the work to be done.

Mayor Silvestre Garcia asked the City Counsel Judge Gilberto Hinojosa if the city was obligated to take the lowest bid. Judge Gilberto Hinojosa responded to the question, stating that the law specifies that the lowest bid of the most qualified sub-contractor, unless there is a special circumstance that requires not to take the lowest bid. (examples given)

Mayor Pro Tem Commissioner Mary David recommended and felt Sparky Lighting is more qualified for the job.
